FOOD AND CIVIL SUPPLIES (B) DEPARTMENT

The Assam Paddy and Rice Procedure (Leavy and Licensing) Permanent Order, 1995

NOTIFICATION

The 4th December, 1995

No. FSB. 291/95.—Whereas the Governor of Assam is of the opinion that it is necessary and expedient so to do for maintaining the supplies of rice and for securing an equitable distribution and availability at fair prices.

Now, therefore, in exercise of the powered conferred under Section 3 of the Essential Commodities Act, 1955 (Act 10 of 1955) read with the Government of India, Ministry of Agriculture (Department of Food) Order No. G.S.R. 452(E), dated the 25th October, 1972 and G.S.R. 800, dated the 9th June, 1978, the Governor Assam with prior concurrence of the Central Government is pleased to make the following order, namely: -

1. SHORT TITLE, EXTENT AND COMMENCEMENT:

- (1) This order may be called the Assam Paddy and Rice Procurement (Levy and Licensing) Permanent Order, 1995.
- (2) It extends to the whole of the State of Assam;
- (3) It shall be deemed to have come into force with effect from 1st October, 1995.

2. DEFINITIONS:

In this order, unless the context otherwise requires –

(a) **"Deputy Commissioner"** means the Deputy Commissioner of a District, and shall be deemed to include the Additional Deputy Commissioner, the Subdivisional Officer of a Civil, Sub-division or any other Officer duly authorized by the Government to exercise

- the powers of the Deputy Commissioner under this order man be specified in the said authorisation;
- (b) **"Appellate authority"** means the Deputy Commissioner of the District;
- (c) **"Government"** means the State Government of Assam;
- (d) **"Licensed Dealer"** means a person holding valid licence under this Order;
- (e) "Licensed Miller" means the owner or other persons(s) in charge of a rice mill or a chira mill holding a valid licence under the Rice Milling Industry (Regulation) Act, 1958 (Act 21 of 1958) and includes a person or authority which has the ultimate control over entrusted to the Manager, a Managing Director or a Managing Agent then the said expression shall include such Manager, Managing Director or Managing Agent;
- (f) **"Paddy"** and **"Rice"** means paddy and rice of the varieties described in Schedule-I and Schedule-II respectively;
- (g) **"Procurement Agent"** means the Assam State Cooperative Marketing and Consumers Federation Limited (STATFED), and Food Corporation of India in their respective areas of operation as defined in Schedule to this Order;
- (h) **"Procurement Price"** means the price fixed by the Government for different varieties of paddy and rice which will be intimated from time to time as per specifications to be intimated from time to time in Schedule IV, V or V (A) as the case may be;
- (i) **"Permit"** means a permit by the Deputy Commissioner to a licensed miller to under take custom milling of paddy belonging to cultivator an

- agricultural labourer, a licensed dealer or a consumer only;
- (j) "Release Certificate" means a certificate granted in the Form given in Schedule VI by the Deputy Commissioner or an officer authorised by him to a licensed dealer or a licensed miller in token of his/their, having delivered/sold the required quantity of rice to the Government or to its procuring agent and allowing him/then to disposes of the quantity as specified therein;
- (k) **"Purchase Officer"** means an officer detailed and assigned by the procuring agent of the Government to take delivery of paddy and rice from the licensed dealer and miller;
- (l) **"Rice Mill"** means the plant and machinery with which and the premises including precents thereof in which or in any part of which rice milling operation is carried on;
- (m) "Schedule" means a Schedule to this Order;
- (n) **"Specification"** means the specification prescribed for paddy and rice in Schedule –IV, V and V (A) respectively.
- (o) **"Form"** means the application from for licence and also the prescribed form for issue of licence under this Order;
- (p) **"Enforcement Officer"** means and includes all officers of Food and Civil Supplies Department not below the rank of Sub-Inspector working in District/Civil Sub-division and also includes all Food and Civil Supplies Officers working in the Directorate of Food and Civil Supplies, Assam;
- (q) **"Custom Milling"** means milling of paddy, not belonging to the miller, into rice in his rice mill on payment of milling charges in case or in kind;

- (r) **"STATFED"** means the Assam State Co-operative Marketing and Consumers Federation Limited, Assam established in Assam in 1975.
- (s) **"Food Corporation"** means the Food Corporation of India established under Section 3 of the Food Corporation Act, 1964 (Act 37 of 1964).

3. DEALING TO BE LICENSED:

No dealer or licenses miller shall engaged in any business which involves purchase, sale or storage for sale of paddy and rice except under and in accordance sale of paddy and rice except under and in accordance with the terms and conditions of a licence under this Order;

Provided that a licensed miller having valid milling licence under Rice Milling Industries (Regulation) Act, 1958, shall not be required to obtain a separate dealing licence under this clause;

Provided further that not such licence under this order shall be necessary in the case of a person who purchases, sells or stores for sale paddy not exceeding 10 (Ten) quintals in one calendar day subject to the conditions that within a belt of ½ K.M. from the border with Bangladesh the maximum quantity of paddy n a calendar day which can be purchased sold or stored for sale without a licence shall not exceed 2 (two) quintals;

Provided that nothing in this clause in so far as sale or storage for sale of paddy or rice is concerned shall be applied to producer;

Provided further that nothing in this clause shall apply in so far as sale or storage of paddy and or rice made by the Food Corporation of India or stock held by either on behalf of the Government of India or the State Government.

4. LICENSING OF DEALERS

(1)

- (a) Deputy Commissioner in respect of Sadar Subdivision and Sub-divisional Officer in respect of outlying Sub-division will be the Licencing Authority in their respective areas under this order.
- (b) Wholesaler dealers of rice holding Wholesale Licence under the Assam Trade Articles (Licensing and Control) Order, 1982, are eligible to apply for licence to deal in paddy.
- (c) Every application for a licence under this order shall be made to the Licencing Authority in Form I shown in Schedule- X;
- (d) In granting or refusing licence under this Order, the Licencing Authority shall among other matters, take into consideration the following, namely: -
 - (i) the stock of foodgrains available in the locality for which the licence is required
 - (ii) the number of persons who have applied for and those who have been granted licence in respect of food grains under the order in the locality;
 - (iii) the business ordinarily carried on by the applicant;
 - (iv) the past activities of the applicant as a licencee including discharge of levy liability.

- (2) Notwithstanding anything contained in sub-clause;
 - (i) the State Government may, if it is of the opinion that it is necessary to channelise distribution of foodgrains through any special or specialised agencies or channels direct the Licensing Authority to grant licences under this order to such agencies or channels.
- (3) Every licence issued under this order shall be in Form II or Schedule X
- (4) Every licence issued under this Order shall be valid till the 30th day of September next following the date of issue.
- (5) The fee payable for licence under this Order shall be Rs. 25.00 only.
- (6) Suspension or cancellation of licences;

The authority issuing the licence may, after giving an opportunity of being heard suspend or cancel a licence if any licence either by himself or by an employee acting on his behalf, contravenes any of the provisions of the provisions of this Order or any of the conditions of the licence.

5. LEVY ON MILLERS:

Every licensed miller shall from the date of the commencement of this order deliver to the procurement agent rice at the procurement price at the rate of 50 per centum of the quantity of rice actual milled by him from his own stocks of Paddy;

Provided that the above levy may be compounded at the option of the miller in the manner indicated below: - (a) Rice mills having licenced capacity of 8 tones and above diem

10% of annual licensed capacity and will be discharged in terms of rice

- (b) Rice mils having licensed capacity of 2.5 tones to less than 8 tones or diem
- 5 % of annual licensed capacity and will be discharged in terms of rice
- (c) Rice mill having licenced capacity of less than 2.5 tones per diem
- 4 % of annual licensed capacity and will be discharged in terms of rice

Any Rice Miller can deliver levy in advance if he so desires.

The levy shall be calculated on an average of 200 two hundred working days in a year.

6. LEVY ON DEALERS:

Every licensed dealer sell from the date of commencement of this order at the price notified by the Government to the procurement agent 50% of the rice conforming to specification milled out of the paddy purchased by the dealer under obtained for this purpose.

7. Every licensed miller and licensed dealer shall convert paddy stock at the commencement of this order or received by him thereafter into rice conforming to specification within three months or within such extended time as the Deputy Commissioner may at special circumstances, allow;

Provided, however, that in case of time being extended beyond 3 (three) months the Deputy Commission shall make a report to the Government who may vary, amend such directions: Provided further that in case any licensed miller of licensed dealer fails to discharge his levy liability within the specified time, the Deputy Commissioner may requisition the stocks of rice and of paddy held by the said miller or dealer and abject the same against his levy liability.

Provided further that no paddy shall remain unmilled with the Millers and Dealers at the end of the marketing season in which the paddy has been purchased:

Provided also that no levy shall be payable on any stock of paddy purchased or otherwise acquired by him from a licensed miller or licensed dealer in respect of which levy has been delivered to the Government and certificate obtained from competent authority of the due discharge of levy liability.

Provided also that millers and dealers shall be liable to comply with any director issued by State Government to secure implementation of this Order.

8. SEPARATE ACCOUNTS ON CUSTOM MILLING BY RICE MILLS:

Every rice miller shall maintain separate accounts in respect of customs milling undertaken by him/them in addition to normal maintenance of accounts of paddy purchased and rice recovered after milling paddy and other by-products in accordance with the provision (s) of the Rice Milling Industry (Regulation) Act, 1958.

9. LEVY RICE TO CONFORM TO SPECIFICATIONS AND DELIVERY THEREOF:

(1) The paddy rice required to be sold to the procurement agent under this Order shall conform to the specifications of rice for fair average quality prescribed from time to time applicable to the respective variety of paddy/ rice and shall not contain refractions beyond the reject limit shown therein and in case any stock of paddy/rice offered fro sale does not conform to such specification it shall be reconditioned or rectified by

the licensed miller or the licenced dealer, as the case may be before being so offered so as to bring it in conformity with such specifications.

(2) The paddy/rice required to be sold to the Procurement Agent under this Order shall be delivered by the rice miller or the licensed dealer, as the case may be to the Purchase Officer, in such lots, in such manner, at such place and in such time as the Government Procurement Agent or the Purchase Officer may direct:

Provided that with a view to achieving maximum procurement Government may allow interchangeability if common rice is delivered for purpose of levy in lieu of fine varieties and not vice versa.

(3) The mode of payment for the levy paddy/rice by the Procurement Agent and other matters incidental be determined according delivery of levy paddy / rice shall be determined according to instructions issued by the Government from time to time.

10. RESTRICTION ON SALE AND MOVEMENT OF PADDY/RICE

- (1) No licenced miller/dealer shall sell or agree to sell of otherwise dispose of the paddy purchased or acquired or the rice recovered by milling other than the quantity specified the clauses 5 and 6 as the case may be except in accordance with the Release Certificate issued by the Deputy Commissioner or any other authorised officer.
- (2) Save as otherwise provided in sub-clause (1) thee will be no restriction in respect of free movement of rice / paddy within the same or to another state within the Indian Union.

11. RELEASE CERTIFICATE:

(1) After delivery of levy paddy/rice, every licences miller/dealer may make application in the from-set-out in Schedule-VI to the Licensing Officer for issue of Release Certificate for disposal of Levy-free stock of rice/paddy. The application referred to herein shall be affixed with non-judicial stamp worth Rs. 1.10 and accompanied by the receipt in original issued by the Purchase Officer in respect of delivery of rice/paddy under levy. After proper scrutiny of the application (s) for Release Certificate the Licensing Officer shall issue a Release Certificate in the form set in Schedule – VI for movement and disposal of levy free rice.

It Release Certificate cannot be issued in any case the reason and circumstances for which Release Certificate could not be issued shall be recorded in the order and communicated to the applicant (s).

(2) An application for Release Certificate shall be made within one months from the date of delivery of levy paddy/rice of rice in respect of which such Release Certificate is issued shall be disposed of by the licensed miller/ dealer within a period of 15 (fifteen) days from the date of such Release Certificate:

Provided that the period specified above may be relaxed by the State Government or by the Director, Food and Civil Supplies for reason to be recorded in writing:

12. POWERS TO REQUIRE RICE MILL-TO-MILL PADDY:

(1) The Government may direct any licensed miller to convert into rice any quantity of paddy held by the Government or by its agencies or the Food Corporation of India, on such terms and conditions as may be notified by the Government from time to time:

Provide that the quantity of paddy to be given to a rice mill by the Government or its agencies or by the Good Corporation of India, during one Kharif Season beginning from 1st October shall not exceed 40 (forth) per cent of the annual licenced milling capacity to be calculated on an average of 200 (two hundred) working days.

EXPLANATON:

For purpose of this clause, the licensed milling capacity f any licensed mill shall be the same as mentioned in the licence issued under the Rice Milling Industry (Regulation) Act, 1958 and the Rule made thereunder.

13. POWER TO EXEMPT:

- (1) The Government may, in public interest, exempt any area from levy or reduce quantum of levy in any area, for a particular period/year as may be decided by Government with the prior concurrence of the Central Government.
- (2) The Government may in public interest, exempt any class of persons from levy with the prior concurrence of the Central Government.

14. MAINTENANCE OF ACCOUNTS & SUBMISSION OF FORTNIGHTLY RETURN:

(1) Every licensed miller and licensed dealer shall maintain register indicating the quantity of paddy milled and rice delivered under levy during under the day in the relevant form.

He shall furnished in fortnightly return containing an abstract of the above accounts for fortnightly period ending on the 15th and the last date of every calendar month 10 the Deputy Commissioner exercising jurisdiction in the area so as to reach him within 5 days of the close of the fortnight.

15. NOTIFIED AREA:

The Government may declare any are/areas within the State as notified area/areas during the period from the month of November to February, Transaction in rice and paddy in such Notified Area/Areas shall be conducted according to such Government instructions and controlled by such Government agencies as may be specified by the Government from time to time.

16. PERIODICAL VERIFICATION OF STOCKS WITH MILLER / DEALER:

- (1) The Enforcement Officer shall periodically, which shall not be less than once a fortnight, verify the rice / paddy stock (s) in the mill or available with the dealer (s) and issue a certificate indicating therein the date and time of verification and the quantity of rice / paddy found on verification, varieties, quantity already delivered old as levy liability, quantity disposed of as per Release Certificate, if discharged/delivered/ sold by the miller/dealer. The Certificate must bear the signature and designation of Enforcement Officer, as well as the signature of the licensed miller/ dealer as a token of its correctness.
- (2) Copies of the above Certificate shall be furnished within 3(three) days to the Deputy Commissioner exercising jurisdiction in the area (s) and to the purchase officer.

17. POWERS OF ENTRY SEARCH AND SEIZURE:

- (1) The Enforcement Officer may, with a view to securing compliance with this order and of satisfying himself if that is order has been complied with: -
 - (a) inspect or cause to be inspected any book or document or accounts as well as any stock of

rich or paddy belonging to or under the control of a miller or dealer:

- (b) require any person to give any information in his possession in respect of any undertaking of business for production or manufacture of rice or for purchase or sale or storage for sale of rice or paddy;
- (c) stop and search forthwith, with such aid or assistance as may be necessary any person or vehicle or vessel or animal used or respected of being used for delivery of rice or paddy from the miller/dealer to other premises of the miller/dealer where he has reason to sell rice or paddy if stored:
- (d) enter and search, with such aid or assistance as may be necessary such mill or other premises;
- (e) seize and remove, with such aid or assistance as may be necessary -
 - (i) any stock of rice or paddy in respect of which or part of which, he has reason to believe a contravention of any of the provisions of this order ha been or is being or is about to be committed.
 - (ii) any package, covering or receptable in which such stock of rice or paddy is found; and
 - (iii) animal, vehicle, vessel or other conveyance used in carrying such stock of rice & paddy if he has reason to believe that such animal, vehicle, vessel of other conveyance is liable to be forfeited under provisions of the Essential Commodities Act, 1955 and thereafter unreasonable delay, without make report to the Deputy Commissioner under

the provisions of Section – A of the said Act.

- (f) seize and remove any books of accounts or documents which in his opinion shall be useful for relevant to any proceeding in respect of any contravention of this order and allow the person from whose custody such back of accounts or documents are seized to make copies thereof to take extracts therefrom in his presence.
- **18.** The provisions of the Code of Criminal Procedure 1978 relating to search and seizure shall apply to searches and seizure under these clauses.

19. APPEAL:

- (1) Any miller or dealer or other person aggrieved by the order of the purchases officer fixing the quantum of law under any of the clauses 5 & 6 as the case may be within seven days from the date of service of such order, appeal to the Deputy Commissioner exercising jurisdiction in the area in which the mills of the milers of the business premises of the dealer is situated.
- (2) The Deputy Commissioner shall fix the date, time and place for hearing the appeal thus preferred to him and may from time to time adjourn the hearing and make or cause to be made such further enquires as he deems fit.
- (3) In disposing of n appeal, the Deputy Commissioner may confirm or amend the order appealed against or enhance the quantity of rice to be sold under the said order.
- (4) The Deputy Commissioner shall communicate in writing the order passed in appeal by him to the appellant and also to the purchase officer concerned.
- (5) The appellant may, however, appeal to the State Government against such orders passed by the Deputy

Commissioner within seven days and the State Government shall have powers to review such orders.

20. PENALTY:

If any licensed miller/dealer, contravences, whether knowingly, intentionally or otherwise, any provisions of this order, he shall be punishable in accordance with Section 7 of the Essential Commodities Act, 1955 (Central Act I of 1955).

21. REPEAL AND SAVING:

The Assam paddy and Rice Procurement (Licensing and Levy) Order, 1994 is hereby repealed provided that such repeal shall not affect:

- (a) the previous operation of the said order or anything duly done or suffered thereunder; or
- (b) any right, privilege, obligation or liability acquired or incurred under the said order; or
- (c) any penalty forfeiture or punishment incurred in respect in any offence committed against the said order; or
- (d) any investigation, legal proceedings or remedy in respect of any such right privilege, obligation, liability, penalty, forfeiture or punishment as aforesaid and any such investigation, legal proceeding or remedy may be instated continued or enforcement and any other penalty, forfeiture or punishment may be imposed, as if the said order has not been repealed.
